Projects will elaborate a detailed plan on how to use the results, i.e. the subsequent transport, utilisation and/or underground storage of the captured CO2. Important aspects to address are of technical (e.g. the optimised integration of capture plant with industrial processes; scalability; CO2 purity), safety (e.g. during transportation and storage), financial (e.g. cost of capture; cost of integration) and strategic nature (e.g. business models; operation and logistics of industrial clusters and networks).</p> <p>Projects are expected to bring technologies to TRL 6-7 (please see part G of the General Annexes).
